The Budget Hearing for Avery Township FY 2018/2019 was called to order by Thom Seymour, Supervisor, at 6:00 p.m. at the Avery Township Hall with the Pledge to the American Flag..

Motion by Jean Angell, seconded by Gary, McMurphy to correct time on the March 6, 2018 Agenda for the Public Hearing to 6:00 p.m. All in favor, motion carried. 5 Yeas 0 No

Motion by Jean Angell, seconded by Gary McMurphy to approve the minutes of the March 9, 2017 Budget Hearing as presented. All in favor, motion carried. 5 Yeas 0 No

Supervisor Thom Seymour read the following to fulfill the requirements for the Headlee rollback to be included in the minutes of the FY 2018/2019 Budget Hearing, including discussion on same as follows:

The property Tax Millage Rate proposed to be levied to support the proposed budget will be a subject of this hearing.

Reviewed the Property Tax Rate proposed to be levied to support the proposed budget for FY 2018/2019 for the General Fund for the Township of Avery.

The proposed FY 2018/2019 Budget was reviewed by line item including salary increases for the Supervisor, Treasurer, Clerk, Two Trustees, Deputy Treasurer, Deputy Clerk, Zoning Administrator, and maintenance man by a 2% increase. ~~The hourly rate and per diems~~ to remain the same at the FY 2017/2018 rate.

Motion by Gary McMurphy, seconded by Jean Angell, to increase the salaries of the Supervisor, Treasurer, Clerk, two (2) Trustees, Deputy Clerk, Deputy Treasurer, Zoning Administrator and Maintenance Man by 2% for the FY 2018/2019 Fiscal year. All in favor, motion carried. 4 Yeas 1 No

After review of the Park Control the decision for record that no major improvements were going to be made to the park this fiscal year.

After discussion motion by Jean Angell, seconded by Gary Mc Murphy, that we allocate, appropriate and adopt the FY 2018/2019 Proposed Budget as submitted Supervisor called for the following Roll Call vote:
