

**AVERY TOWNSHIP BOARD
REGULAR MONTHLY MEETING
October 6, 2020**

Supervisor Thom Seymour called the regular monthly meeting of the Avery Township Board to order at the Avery Township Hall with the Pledge to the American Flag at 6:00.p.m.

Motion by Gary McMprhy, seconded by Jean Angell to accept the minutes of the September 1, 2020 regular monthly meeting as submitted. All in favor, motion carried.

Motion by Ann Seymour seconded by Gary McMurphy to accept the Treasurer's report as submitted. All in favor, motion carried.

Motion by Jen Angell, seconded by Gary McMurphy to pay vouchers #4213- #4334 inclusive totaling \$6,904.44. All in favor, motion carried.

Supervisor updated on the joint meetings with the other 7 Townships regarding Interlocal Agreement for Designated Assessor.

Motion Jean Angell, seconded by Thom Seymour to address a letter to the Montmorency County Commissioners rejecting the signing of the InterLocal Agreement for Designated Assessor. Ayes 4 No 0 Absent 1. Motion carried.

Clerk addressed the Board regarding the need for purchasing "Microsoft software" for the township computers as it is impossible at the present time to access other programs that are necessary. Motion by Jean Angell, seconded by Gry McMurphy that we authorize the purchase of "Microsoft" for the Township computers. All in favor, motion carried.

AIRPORT REPORT: Presented by Jean Angell. Advised that the Airport Board met with the USAF for possible usage of the Airport. Any improvements they may make if they do use our airport will be at no cost to the Airport.

AMBULANCE REPORT: Presented by Thom Seymour.
